

MILWAUKEE BANGERS BASEBALL – LIABILITY AND IDEMNIFICATION WAIVER

Section 1. I hereby consent and agree to the following parameters as conditions of participation in Milwaukee Bangers Baseball (MBB) practices, games, leagues, tournaments, events, and/or other functions.

Section 2. I am aware of and agree to the team rules and guidelines regarding player conduct. I understand that these rules apply to me.

Section 3. I understand that violation of any part of this waiver or team rules and guidelines can result in disciplinary action against me, including suspension from play or permanent expulsion from this team and/or MBB practices, games, leagues, tournaments, events, and/or other functions.

Section 4. I understand that MBB reserves the right to refuse any player or team permission to play in any MBB event, including practices, games, leagues, tournaments, events, and/or other functions.

Section 5. I understand the risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions. I understand it is impossible to eliminate that risk, and that I could be exposed to and/or become infected through contact with, or being near, an individual with a communicable disease.

Section 6. I realize that the total responsibility of any personal injury, accident, illness, disability, death, property damage, lawsuit, legal issues, and/or other occurrence to any person, place, or thing, including me and mine, that occurs due to my actions or the actions of others while I am participating in any MBB practice, game, league, tournament, event, and/or other function, is solely mine.

Section 7. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of others, and assume all and full responsibility for my participation in any MBB practice, game, league, tournament, event, and/or other function.

Section 8. I understand that photographs and/or video recordings of me and my likeness may be taken while participating in MBB practices, games, leagues, tournaments, events, and/or other functions and shared publicly. I consent to photographs and/or video recordings of me and my likeness being taken and shared on the MBB website, MBB social media platforms, separate organization's websites, separate organization's social media, and member's individual social media accounts.

Section 9. I understand that my first name, last name, or full name may be shared publicly by MBB for entertainment, promotional, informational, or marketing purposes. I consent to my name being shared on the MBB website, MBB social media platforms, separate organization's websites, separate organization's social media, and member's individual social media accounts.

Section 10. In consideration of the foregoing and being allowed to participate in the MBB activities or functions, including, but not limited to, practices, games, leagues, tournaments, events, and meetings, and intending to be legally bound for myself, my heirs, executors and administrators, I do hereby release and discharge MBB, including but not limited to, its officers, directors, agents, contractors and employees, any city, county, and/or state organization or any other governing body that may have jurisdiction over any baseball field or other facility that I and the team might play on, any other owners, lessors or provider of fields or facilities (whether privately held or otherwise), any umpires or umpire organizations, and their respective officers, directors, agents, contractors, employees and other players in the association, jointly and severally, from any and all liability from personal injury, accident, illness, disability, death, property damage, legal issue, lawsuit or other occurrence which I and the team may suffer in any manner whatsoever arising out of or resulting from my participation in this league or any MBB activity or function held in conjunction therewith; and I expressly assume all risk of my participation in these activities or functions.

Section 11. I have read this waiver in its entirety as well as the team rules and guidelines. I understand and agree to the content of these documents. I understand and agree that this waiver, my understanding of it, and my consent applies to any MBB practice, game, league, tournament, and/or other function that I participate in going forward.
